Census Dates
The census date is the last date which students can withdraw from the course without incurring a debt for the course or part of the course. A student's census date is calculated as their nominated start date plus 20% of the course duration. HERC will provide a fee schedule to all enrolling students with Census Dates so students can be aware of their Census Dates as required by law.

Additional Fees and Charges		
Assessment		
All course fees include up to three (3) attempts at assessment per unit. Where an additional assessment is required in order to achieve competency, these additional re-assessment fees will be charged per additional assessment.		
Late Assessments	Assessment submitted more than 7 days beyond the due date without an extension will attract a late fee.	\$20
Practical Assessment	Includes any assessment where the student is required to make a presentation to an assessor (practical exam in simulation, oral reports). If a student misses an assessment that includes hire of equipment or engagement of a subject matter expert, the student may be asked to cover the cost of re-hire/engagement.	\$50 per hour
Theory Assessment	Written test, assignment, or project	\$50 per hour
Additional clinical placement	Should any additional placement be required, it is at the expense of the student	\$80 per day
Additional Tuition		
All course fees include tuition and student support. Where students require ongoing additional tuition beyond the two hours for each competency, these additional tuition fees will be charged per hour.

Re-issuing of HERC issued qualification testamurs and academic transcripts		
All course fees include the cost for issuing of 1 copy of a qualification Testamur and academic transcript. These fees apply to each additional copy of a qualification Testamur and/or academic transcript.

Recognition of Prior Learning (RPL)		
There is a cost for RPL if you are seeking RPL then you should contact HERC and discuss. A cost for RPL will be provided and will require payment of a deposit to lodge the application for formal assessment and a cost for each assessment. The fee range for RPL is a minimum of \$200 and a maximum determined on a case by case basis. Any RPL fee will be determined and the applicant notified before the assessment is undertaken.
